I understand that I or my insurance carrier is responsible for any liability for any injury or damage to property caused by me in my capacity as operator of the ECV. Further, Colchester Zoo, their affiliates, agents, employees and ScooterBug, Inc. providing this ECV shall not be liable for or responsible for, and shall be saved and held harmless by me from and against any and all claims and damages of every kind, injury to or death of any person or persons and for damage to or loss of property arising out of or attributed, directly to the use of the ECV. I understand that ECV shall not be taken off the premises of Colchester Zoo. If so, I will be responsible and liable for any injuries and damages associated with the ECV.
